OVERVIEW

I hold the rank of Distinguished Professor at Wayne State University (an R1, Highest Research Activity institution) and am a licensed psychologist. My research program is internationally recognized for scholarship linking stress and emotional processes (e.g., alexithymia, emotional disclosure, emotional expression) to health, particularly chronic pain disorders. I have been continuously funded by the National Institutes of Health for two decades, have published nearly 200 peer-reviewed articles (Google Scholar h-index = 76), and am a Fellow of several professional societies. I have specific expertise in the development and testing of psychological interventions for people with chronic pain, including emotional disclosure techniques and Emotional Awareness and Expression Therapy (EAET), which I co-developed. My colleagues and I have demonstrated the benefits of these approaches in many small- and large-scale randomized clinical trials. We are encouraging the field to improve chronic pain treatment by considering the possibility of recovery from chronic pain and by targeting patients' trauma and emotional conflict via emotional processing. EAET is listed as an evidence-based treatment option in the 2019 U.S. Department of Health and Human Services Pain Management Best Practices Inter-agency Task Force Report. A minor line of research that I have conducted examines stress and health in Middle Eastern refugees and Arab Americans. Finally, I have been a very dedicated doctoral mentor, graduating nearly 50 PhD students, who have taken a wide range of academic, training, and clinical positions. I also directed Wayne State's Ph.D. program in clinical psychology from 2005 until 2022.
