2024 – 2029 **MPSI Project LAUNCH: Promoting Young Child Wellness in Detroit**

The goals of MPSI-PL are to: 1) conduct culturally appropriate behavioral health screening and assessments of children birth-8 years old and their parents/caregivers, 2) provide infant and early childhood mental health intervention services, 3) provide family and parent training about early child development and culturally appropriate and effective parenting strategies, 4) provide behavioral health training in primary care settings as part of integrated pediatric primary care, 5) provide mental health consultation in early care and education settings, and 6) establish a Detroit Young Child Wellness Council (DYCWC).

2022 – 2027 **An Early Childhood System of Care Approach to Integrating and Expanding Michigan's Baby Courts.**

In this project, we evaluate Michigan's efforts to (1) Develop statewide and local infrastructure to support the implementation and expansion of the SBCT approach; (2) Advance partnerships across systems and programs to support the health and well-being of the priority population; and (3) Use data to measure needs, inform continuous quality improvement (CQI), and evaluate outcomes of the project. These goals align with the national Infant Toddler Court Program. The evaluation team from Wayne State University has a history partnering with the MI Department of Health and Human Services (MDHHS) on child welfare and early childhood mental health evaluations and continuous quality improvement (CQI) efforts and they bring expertise in implementation science, quantitative and qualitative analyses that will support a mixed methods process and outcomes evaluation that measures reach, fidelity, implementation drivers, barriers, and solutions, and the impact of Baby Courts on safety, permanency, and well-being.

This project aims to develop a set of self-paced, on-line training modules for Baby Court to address the critical challenge of maintaining a knowledgeable and collaborative workforce that can sustain and grow the initiative. Baby Court, a science-informed collaborative court model, uses existing services to improve the caregiving environments for Michigan's most vulnerable residents: maltreated young children under the age of 5. A knowledgeable and collaborative workforce ensures fidelity to the Baby Court model, resulting in continued positive outcomes such as: being reunified with parents, protection from the recurrence of maltreatment, and a reduction in developmental delays and behavior problems (\$499,788)

2015-2021 **Recognizing, Reflecting and Responding to Infant/Toddler Cues: An Integrated Parent-Teacher Intervention to Support Social Emotional Development through Caregiver Mindfulness and Sensitivity (90YR0092).**

The purpose of this project is to develop an integrated intervention for EHS parents and teachers. We offer an attachment-based group intervention to both parents and teachers to help them understand children's attachment needs using video and activities designed to promote reflective functioning and increase caregiver coping and mindfulness practices. In this 5-year project we develop and pilot the integrated intervention, test the efficacy of the intervention, in an open trial and an RCT, to change caregivers' mindfulness practices, reflective functioning and caregiver-child interactions and scale up the project within the EHS sites. The aim of this project was to scale-up and evaluate the Wayne County Baby Court project. Baby Court brings the science of child development to the courtroom by involving a team of science-informed professionals (therapists, foster care workers and attorneys) to work as a team with families whose children have been removed from their care and are under court jurisdiction for child maltreatment. Together this team takes into account the needs of the infant while

attempting to significantly change the parents' competence to care for their children. All families receive Infant Mental Health Therapy. As part of the scale-up we worked across systems to develop a cross-disciplinary training. The evaluation assessed the degree to which Baby Court was effective at (1) improving the parent-child relationship and parent reflective functioning; (2) reducing infants' developmental delays; and (3) increasing infants' safety and permanency.
